As part of its provision of services, Everbridge's Critical Event Management Platform will send alerts and messages at your direction to identified devices using standard protocols you choose (such as email, SMS), wherever they are in the world. That means that the messages will transit and be routed through telecommunications providers globally to reach the devices of designated end recipients. Because Everbridge cannot predict where a particular recipient will travel or how messages will be routed over a network, we cannot predict what telecommunications providers might process those messages in the process of transmitting them to the recipient. A list of the potential telecommunications providers is included below under "Available Communication Delivery Channels."

Everbridge's Critical Event Management Platform includes the following products: Mass Notification, Safety Connection, Visual Command Center (VCC), Crisis Management, IT Alerting, and Travel Protector.
